- Oversight Hearing on the Office of Planning and Historic Preservation Office,
 February 9, 2012: CHRS signed onto testimony offered by the Historic Districts Coalition.
- <u>HPO Design Guidelines</u>: HPO is requesting comment on Utility Meters. Shauna will provide comments.
- <u>1310 East Capitol Street, NE, HPA 11-488</u>: Shauna testified at the Mayor's Agent Hearing on February 10, 2012. The Mayor's Agent decision will be announced at a later date.
- <u>Preservation Café</u>: Will feature HPRB staff member Amanda Molson on March 21.

Eastern Market Governance Legislation – Monte Edwards

- EMCAC submitted a report to Councilmember Wells on February 3, 2012 outlining 15 concerns with the proposed legislation, including preservation of flea market space and community use spaces.
- Paul or Chuck will add an ANC link to the CHRS website.

Transportation – Shauna Holmes

• CSX/Virginia Avenue Tunnel (VAT): Shauna attended the first Section 106 review meeting of consulting parties in mid February. All the organizations CHRS recommended for consulting party status were invited. In addition the Navy Yard, NAVFAC, the Marine Barracks and the Historic Districts Coalition will be cooperating parties. The next step is to identify and address adverse effects. CSX is winnowing down alternatives and will make a presentation in March. Monte suggested that Councilmember Wells be informed of the potential impacts on the City.

Zoning – Gary Peterson

- A report was included in the packet regarding six BZA cases and one Zoning Commission case (Hine School) to be discussed at the March 15 Committee meeting.
- The Committee is seeking additional members.
- Gary distributed and discussed the Zoning Rewrite Task Force's proposed updates to residential zoning requirements. They will be posted on the CHRS web site.
- Hine: The first Design Committee meeting will take place February 22. CHRS should consider a Special Membership Meeting in May or June to discuss the Planned Unit Development.

<u>Community Development</u> – Monte Edwards

• Northeast Library: On March 10 the library will celebrate the 80th anniversary of its opening in 1932. Historian and George Washinton University professor John Vlach will narrate a slide show of photographs from the 1930's.
