Historic Preservation – Shauna Holmes

- Shauna Holmes testified at HPRB on behalf of CHRS on November 1, 2012. A copy of
 the testimony in which CHRS opposed locating a streetcar Car Barn on the campus of
 Spingarn High School, as well as the proposed design of the Car Barn, is in the Board
 packet.
- CHRS also testified in support of rehabilitating the **Salvation Army building** at 1211 G Street, SE, for adaptive reuse as apartments and construction of a new apartment building next door on the site of a corner parking lot.
- Section 106 comments on Union Station's Main Hall project were due November 15. The CHRS comment letter is in the Board packet. In brief, we opposed it, as did every other organization in the Union Station Preservation Coalition. In addition, the Coalition had a very productive meeting on November 15 with Amtrak, Akridge, and the Union Station Redevelopment Corporation at which CHRS was represented by Drury Tallant and Shauna Holmes.
- CHRS will also present testimony at the November 29 HPRB meeting on two projects and the **nomination of Spingarn High School** to the DC Inventory of Historic Sites and the National Register of Historic Places. The letters to HPRB from the CHRS Historic Preservation Committee regarding the two projects are in the Board packet.
 - o **901 D Street NE (former Edmonds School)** The Committee supports renovation of the Edmonds School for adaptive reuse for condos and constructing four new townhouses on the school site.

- o 319 A Street NE (rear, in Millers Court) The Committee supports the proposed design of a new 2-story alley dwelling on the site of two 1-story garages, with suggestions for revisiting some design elements. It also expressed concern about decades of demolition by neglect of the historic garage that would demolished for the new residence, as well as the message that would be sent should its demolition be approved. The Committee neither supports nor opposes demolition of the historic secondary structure.
- CHRS also submitted **Section 106 comments on the Virginia Avenue Tunnel Project**'s preliminary assessment of effects on historic properties. A copy of the letter is in the Board packet. In brief, we agreed the project will have adverse effects on the Capitol Hill Historic District, the L'Enfant Plan for the City of Washington, and the historic tunnel itself; made the case for considering a broader range of effects; and expressed concern about how permanent tracks in Alternative 3 and a temporary runaround track in Alternative 2 would go even closer to fragile historic structures than we had previously thought.
