# Historic Preservation: -Shauna Holmes

- Historic Preservation Review Board met on March 28<sup>th</sup> and April 4<sup>th</sup>; see attached testimonies in the packet.
- Banana Café is redoing its façade and wants to have poles cemented into place for retractable awnings. This means all winter long these poles will just be sticking up out of the ground.
- Beer garden below the freeway is coming; the structure is stucco with no windows, and the bar is open.
- Frager's wants to close in the alley space on 11<sup>th</sup> street in all glass with a door. This will be a retail space.
- 423 NJ wants to build over the current driveway and dig out a garage at basement level. In addition they want a 4<sup>th</sup> floor popup in back. They presented in 2004 to HPRB and received a permit in 2007; the permit has expired and they are resubmitting.
- The car barn at Spingarn is on the HPRB agenda again.
- Comments on the city's 2016 Historic Preservation Plan are due 30 of April, and our Historic Preservation Committee plans to submit something.
