APTICLES OF INCORPORATION OF CAPITOL HILL RESTORATION SOCIETY, INC.

To: The Recorder of Beeds, D.C. Washington, D.C.

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation, adopt the following Articles of Incorporation pursuant to the District of Columbia Nonprofit Corporation Act:

 ${\tt FIRST:}$ $\;$ The name of the corporation is Capitol Hill Restoration Society, Inc.

SECOND: The period of duration is perpetual.

THIRD: The corporation is organized for the following purposes:

- (1) to support the improvement and preservation of Capitol Hill as a model urban residential area;
- (2) to preserve, support, disseminate, and encourage good practices in preserving and restoring buildings and sites on Capitol Hill:
- (3) to present the views of its members to other organizations, the public, and governments; and
- (4) to engage in any lawful activity which may serve the interests of its members.

FOURTH: The corporation shall have members who shall be admitted to member thip as provided in the bylaws of the corporation.

FIFTH: The corporation shall have only one class of membership, which shall be composed only of individuals. The qualifications and rights of members, including their right to vote on any matter, shall be as provided in the bylaws of the corporation.

SIXTE: The directors shall be elected or appointed as provided in the bylaws of the corporation.


SEVENTH: The regulation of the internal affairs of the corporation shall be as provided in the bylaws of the corporation.
