**RELEASE AND INDEMNITY AGREEMENT**

Capitol Hill Restoration Society ("Manager"), as a courtesy and accommodation to \_\_\_\_\_ (hereinafter, "Releasor"), agrees to allow Releasor to engage only in the following activity: 2018 Home Expo (collectively referred to as the "Activity") on Sunday, October 21, 2018 at the Eastern Market North Hall, 7th Street, SE, Washington, DC. Releasor agrees to return the Eastern Market North Hall in good condition and repair at the conclusion of the Activity. Releasor hereby covenants and represents to Manager that: (i) Releasor will use the Activity only for the Activity, and in compliance with all applicable laws, codes, rules and regulations, and (ii) Releasor shall conduct the Activity in a manner as not to create any nuisance, or interfere with, annoy or disturb any tenant, occupant or invitee of the Eastern Market in its operation of the Activity. In consideration of Manager's agreement to permit Releasor to engage in the Activity, Releasor wishes, by this Release and Indemnity Agreement, to memorialize its agreement not to assert against Manager or the District of Columbia, and further to hold Manager and the District of Columbia harmless against, any costs or liabilities associated with the Activity and Releasor's use of the Eastern Market North Hall. Accordingly, Releasor, for itself and its trustees, members, principals, beneficiaries, partners, officers, directors, employees, agents, successors, insurers, affiliated and related companies, and assigns, and each of their agents and employees (all of the foregoing, "Affiliates"), hereby releases and forever discharges the District of Columbia, and Manager and its Affiliates, officers, partners, shareholders and each of them, from any and all rights, damages, penalties, actions, claims, demands, losses, obligations or liabilities of whatever nature, including all attorney fees and other fees, charges, costs and expenses, at law, in equity or otherwise, arising out of or related in any manner to the Activity, including any latent defects, or the use of the Activity by Releasor or any of Releasor's Affiliates (all of the foregoing, "Claims"). Releasor and its Affiliates shall indemnify, defend and hold harmless Manager and the District of Columbia from and against any and all Claims.

This Release constitutes the entire agreement of the parties with respect to the Activity and Claims and may not be modified except in writing signed by both parties.
