Thank you for your interest in the Swampoodle Grants Program. The goal of the program is to help restore homes in the Swampoodle neighborhood ((Squares 752,753,777,778)) to a style consistent with its period of significance, approximately 1880-1910, and to make homes more energy efficient.

II. Description of Proposed Work (please include all of the following):

1. A brief but detailed description of the Scope of Work and the reason for the project. Scope of Work should include an explanation of how the work will conform with the house's original design elements.
2. Photos that *clearly* show item(s) to be altered, repaired, or improved.
3. Architectural drawings of the proposed work, if available. If not, please annotate, and/or adjust using Photoshop or similar tool, the "before" photos to show proposed improvements.
4. A Cost Estimate/Proposal from a licensed contractor. Proposal should indicate what materials the contractor will use and what measures the contractor will take to ensure that the work is historically appropriate. If uncertain, contractor should consult historic preservation guidelines.

For energy efficiency grants:

1. Indicate if you are applying for a "micro-grant" (e.g., for re-lamping with LED bulbs).

2. If the proposal is for insulation, new windows, HVAC, solar panels, etc., provide a description of how the proposed improvement will save energy in addition to cost estimate and contractor's proposal.

*PLEASE NOTE: The proposed work must be approved in writing, by CHRS, as conforming with the above historic guidelines in order to receive payment. Conformance will be evaluated during proposal review and again after completion of the work. If you or your contractor are uncertain about whether or not your project conforms, please direct your questions to CHRS: caphrs420@gmail.com. The Grants Committee will be happy to provide guidance. The Grants Committee, will evaluate other aspects of eligibility as well. **Please do not begin construction until you have a signed letter of approval from CHRS.** If construction begins prior to receipt of a signed approval letter, funding will NOT be approved.*

You will be notified by letter regarding approval or disapproval of your application. Please allow 4-6 weeks for notification. Please be advised that payment will NOT be approved if the work was begun before receipt of written authorization.
